For my multi-method qualitative dissertation entitled "What Does it Mean to be Deaf? Changing Meanings of Deafness, Communication Technology, and Beliefs about Normality in the US," I employed historical content analysis of newspaper and magazine articles, as well as contemporary hearing aid and cochlear implant advertisements and websites. I also interviewed 33 parents about their decision-making process to implant their young deaf children with cochlear implants. My major findings were that the "meanings of deafness" have changed at least four times since the early 1700's, and that the meaning of deafness in each era influenced which technologies were leveraged to address the problem as it was identified. Conversely, available technological capacity informed the meaning of deafness. Advertisements and websites for hearing aids and cochlear implants highlight these meanings of deafness and how their technologies address those meanings. Interviews with parents revealed that they used discourses of normality, medicalization, and stigma when making the cochlear implant decision.
